| Broker's Report<br>SELF   | The broker, Bill Tucker Jr. briefly spoke on the S.E.L.F. rates for 2010/11, comparing their rate of \$2.95/ADA at the \$25 Mil x of \$5 Mil layer to that of the NorCal ReLiEF (NCR) rate of \$2.30 at the same coverage layer, or a difference of \$63,000. It was noted NCR does not have the optional excess liability layer of \$20 Mil x of \$5 Mil as does S.E.L.F.   |  |
|                           | If it is the districts' desire to leave S.E.L.F., notice needs to be given by December 31, 2010. - Action Items NCR Rates The broker presented the NCR liability and property rates to the Executive Committee for their recommendation for approval to the Board, (Attachment A). He mentioned it was the best renewal he has seen in six or seven years. The liability rate took a slight decrease over that from the year prior; from \$16.37/ADA to \$16.135/ADA. The property rate took a slight increase from the prior year going from .06317/\$100 TIV to .0644/\$100 TIV. The motion to accept the NCR rates was made by member Teixeira and seconded by member Mungur. Motion carried.
- **OSS Rebate** After a lengthy discussion regarding cash flow and the payment of rebates, the motion to declare the second year rebate payment of \$321,345, (Attachment B) in the 2009/2010 fiscal year and pay it in the 2010/2011 fiscal year was made by member Teixeira and seconded by member Hudson. Motion carried.
