Broker's Report Cont. SELF Invoices	The broker also mentioned his office had received the 05/06 Schools Excess Liability Fund (S.E.L.F.) invoices. The rate increased from \$1.00/ADA for the 04/05 year to \$1.20/ADA for the 05/06 year on the first liability layer of \$10 million excess of \$5 million. The next layer of \$30 million excess of \$15 million increased from \$0.91 to \$0.98/ADA. Should any rebates be declared, it would be in the form of a check to the districts. Due to a discrepancy in ADA, the invoices would be going out to the districts in a week or two.		
Administrator's Report	The claims administrator; Erik Knak was unable to attend the meeting, but left information on the status of the O.S.S. claims:		
	The 6/30/05 open claims count was 54, relatively low when compared to the historical ave FYI, the open claims count has ranged from 50-75 claims over the years. In addition, the 06-30-05 reserves were set at \$656,088.55, a number which should not ca alarm to the JPA.		
Loss Control Report Online Sexual Harassment Training	O.S.S. risk manager, Dr. Henry Brock reported the scheduled completion date for the online sexual harassment training was now 9/1/05. He will be scheduling two sessions for district administrators with the purpose of asking questions of Robert Rosati, attorney used by the O.S.S. to help set up the online training. The scheduled dates and times are October 25 at 4:00 p.m. and October 26 at 4:00 p.m. Each session will be approximately one hour in length and districts will be scheduled according to their location.		
Arson Fires	Dr. Brock mentioned he will be sending out information on arson fires in his next email bulletin.		
Coach Workshop	Dr. Brock reported on an additional workshop he would like to schedule in the spring pertaining to coaches. The all day seminar, <i>Athletic Liability – Minimize the Risk</i> put on by McGrath Training Systems would cost \$180 per person. More information on this workshop will be available at the next quarterly meeting in October.
