Consent Agenda The motion to approve the consent agenda, which included the minutes of the May 17, 2011 meeting as mailed, was made by member Bubar and seconded by member Ford. Motion carried.

Broker's Report JPA Golf Tourney

The broker, Bill Tucker Jr. mentioned the date for the Bill Tucker / Pat Magill Memorial Golf Tournament is Thursday June 14, 2012. Foursomes or individuals are welcomed.

Administrator's Report

The claims administrator for the O.S.S., Erik Knak from Knak & Company, was unable to attend due to a scheduling conflict, but was able to present via speakerphone the O.S.S. Loss History Review – (Incurred) – 5-10-2012 for years 2004-05 through 2011-12. (Attachment A icon below). He mentioned there was an active tail for the 10/11 year. The current year he expects to end with 200 claims and reserves of well over \$1 Mil. He closed by saying the current claim history is the highest he has seen for the O.S.S., both in number and reserves. Vandalism, copper wire thefts, and EDP losses are what are driving the loss trend.



Loss Control Report

AEDs/EpiPens **Concussion Care**

Dr Brock, O.S.S. risk manager mentioned he has sent out several bulletins pertaining to Automated External Defibrillators (AEDs), EpiPens, and concussion care. He stated he would be exploring the possibility of combining the purchasing power of the O.S.S. for providing a group discount for procuring AEDs in addition to providing future servicing & training through the same vendor. Dr. Brock will also be investigating on behalf of O.S.S. members, the Concussion Care Program sponsored by Wells Fargo and what exactly it entails.

Insurance Training

Dr. Brock is currently working on an O.S.S. insurance training DVD which will assist new district insurance personnel in their jobs.

Copper Wire Thefts It was asked of the risk manager to pursue an audit of the districts on their vulnerability for copper wire thefts and what preventive steps can be taken to safeguard against this occurring. He mentioned he would seek out the assistance of Poms & Associates who performs the safety inspections.

Action Items

Loss Fund Rate

The broker presented the loss fund rate at the \$50,000 S.I.R. level with the modified premium for each member, comparing 2012/13 year with that from 2011/12, (Attachment B). The JPA rate of \$18.42 took an increase from the \$17.11 rate of the 2011/12 year. The motion to approve the loss fund rate of \$18.42 was made by member Nikkel and seconded by member Ford. Motion carried.



NCR Rates

The broker presented the NorCal ReLiEF (NCR) liability and property rates to the Board for their approval, (Attachment C). The \$5 Mil liability rate took a 6% decrease over that from the year prior; going from \$16.162/ADA to \$15.161/ADA. The excess liability will be purchased in two layers; \$20 Mil x \$5 Mil with a rate of \$2.41/ADA and \$25 Mil x \$25 Mil with a tentative rate of \$1.46/ADA. The property rate took a slight increase from the prior year going from .0585/\$100 TIV to .0615/\$100 TIV. The broker mentioned NCR applied rate stabilization funding to keep the rates fairly flat. The motion to accept the NCR rates as presented was made by member Cederquist and seconded by member Ford. Motion carried.

The motion to accept the Draft of the O.S.S. Budget as presented by Carol Williamson was made by member Ford and seconded by member Bubar, (Attachment D). Motion carried.



At Large Membership It was moved by member Nikkel and seconded by member Bubar to retain the current slate of at-large members on the Executive Committee with Tony Mendes (Southwest Transportation) and Wes Sever (Kingsburg Jt Union School District) replacing their retiring counterparts, (Attachment E). Motion carried.
