Treasurer's Report	Carol Williamson, the O.S.S. accountant presented the unaudited financial statement for quarter ending June 30, 2013, (Attachment B). Member Williamson noted the auditor would be adjusting any pre-billed expenditures to the 13/14 year at audit.	
Broker's Report Accreditation	The broker, Bill Tucker Jr. mentioned the O.S.S. is in the process of gathering together the necessary paperwork for their re-accreditation. The O.S.S. is accredited with excellence. Part of the excellence requirement involves a Strategic Planning Session. This session will be taking place immediately after the O.S.S. October 17, 2013 meeting.	
Fishing Clubs	Districts are starting to see an interest in fishing clubs by students. Currently only one O.S.S. district has organized such a club. For the time being, the one O.S.S. district's club is bank fishing, but wants to evolve to bass fishing. There is a watercraft exclusion in the MOC as bass fishing involves high speed watercraft. The broker has found a carrier who would write non-owned watercraft liability which would be layered over what the boat owners would have as no boats would be owned by the district. More information will be forthcoming on this subject in the near future.

- Administrator'sThe O.S.S. claims administrator Erik Knak from Knak & Company presented his report, the O.S.S.ReportLoss History Review (Incurred) as of 7-24-2013 for years 2005-06 through 2013-14, (Attachment C).<br/>He mentioned the 2011-12 year was a horrific year for property & liability losses. Copper wire &<br/>computer thefts were driving the property losses. He stated the current 2012-13 year appears also to<br/>be developing worse than the norm. He mentioned the losses for the O.S.S. are paralleling the loss<br/>history of another central valley JPA.
- Loss ControlO.S.S. risk manager; Dr. Henry Brock mentioned districts have shown an interest in holding classesReportfor their staff in aerial & forklift training. He will always try to combine districts if they do not have<br/>enough staff to hold a full class on their own.

Non-Violent Crisis Space is limited to the first 40 registered attendees for the Non-Violent Crisis Intervention Training. Intervention Training This class is scheduled for 9/23/13, 8:30 a.m. to 3:30 p.m. at the Fresno County Office of Education. A bulletin has already been emailed to the districts pertaining to this workshop.

## Action Items

- OSS Tip Program Dr. Brock presented the O.S.S. Tip Program, (Attachment D). This program will be replacing the WeTip program and will allow districts the flexibility to offer a reward to people coming forward with information on vandalism or theft claims. Pre approval of the reward is required and will be under the direction of the O.S.S. TPA, Erik Knak. A sample communication letter to give to the districts was discussed. The motion to approve the O.S.S. Tip Program as presented was made by member Cederquist and seconded by member Singh. Motion carried.
- Agreement between OSS & UC Regents The broker presented the renewal of the five (5) year *Use of Facilities Agreement* between the O.S.S. and the Regents of the University of California for the use of O.S.S. member facilities by 4-H Clubs, (Attachment E). The motion was made by member Cederquist and seconded by member Bubar to approve the five (5) year agreement between the O.S.S. and the Regents of the University of California. Motion carried.
- Election of Officers The motion to nominate the current slate of officers with Trish Singh replacing Diane Augusto as the O.S.S. secretary was made by member Williamson and seconded by member Bubar. Motion carried.
