Auxiliary Organizations Policy Revisions – To have coverage under the MOC, auxiliary organizations (booster clubs) must be formed in compliance with Ed Codes 51520-51521. A handout discussing these guidelines was passed out, (Attachment D). The O.S.S. allows for on premises only liability for groups which have been endorsed under their coverage.
Develving Apoto	Ed Cade 42901 42901 5 requires the person handling revoluing accounts to be handed (Attachment E)

- Revolving Accts Ed Code 42801-42801.5 requires the person handling revolving accounts to be bonded, (Attachment E). The bonding of these employees would be covered under the district's crime policy.
- MOC Renewal The renewal of the MOC has been received and will be distributed to the brokers once the crime policy is received. Tom Russo with Keenan & Associates will check the status of the crime renewal.
- Meeting Time The manager stated there appears to be interest in amending the meeting time of the O.S.S. quarterly Executive Committee to accommodate districts in outreaching areas. A survey will be conducted to gather everyone's input.
- Administrator's The O.S.S. claims administrator Erik Knak from Knak & Company was unable to attend due to a scheduling conflict. His report, *The O.S.S. Loss History Review (Incurred)* as of 07-14-2015, years 2007-08 through 2014-15, was presented by Bill Tucker, (Attachment F). In comparison with the May 2015 report, there are 67 open claims, down by 8, and \$1.21 M in reserves down \$45,000.
- Loss ControlO.S.S. risk manager, Dr. Henry Brock presented his risk management report detailing the various<br/>areas of risk management he is currently involved, (Attachment G):

(1) Planning for the implementation of the revised OSS Strategic Plan has begun. The area of most interest was preparing emergency procedures for each district.
 (2) The Implementation of the California Child Abuse and Neglect Reporting Act (CANRA), AB 1432 continues as this is the first complete school year of its requirements.
 (3) Progress is being made toward the goal of implementing a pilot Return to Work Program.
 (4) *Supervising for Safety* online training is available at Get Safety Trained.com as student supervision continues to account for significant losses to the JPA.
 (5) Information on NCR's Matching Grant Program has been distributed to member districts.
 (6) A newly updated Training Matrix has been sent to districts.
