VI. CLAIMS 2017 / 2018-30

THIRD PARTY ADMINISTRATOR CLAIMS UPDATE

INFO

Erik Knak, Claims Administrator for the O.S.S. presented his report via telephone. The years 2008/09, 2009/10, 2010/11 2011/12, 2012/13 have no claims with 2013/14 having 1 newly opened claim related a to a sexual abuse case involving both the OSS and CRMA. 2014/15 has 2 open claims, 2015/16 has 4 open claims, 2016/17 has 8 open claims, with the current 2017/18 with 19 opens claim for a total of \$521,000 in reserves, down \$139,000 from one year ago. In summary, there has been a sizable reduction in Net Incurred numbers for the 2014/15 and 2015/16 years with 2016/17 looking to be an average year and 2017/18 shaping up to be a very good year, led by excellent General Liability experience thus far. The new 2013/14 abuse claim is indicative of the potential volatility for an older year claims period to incur adverse additional exposure due to the applicability of Civil Code 340.1 or the ability to file an abuse lawsuit up to age 26. This affirms the need for each OSS member to adopt the recommended AR 3320 and BP 3320 changes and incorporate same into an updated claim form.

NORTHERN CALIFORNIA ReLiEF (NCR) UPDATE

- Executive Summaries of the NCR Claims & Coverage, Underwriting, Finance, and Risk Management Committee Meetings were presented.
- 935 Case Law Member Alert The importance of adopting the revised AR 3320, BP 3320 and Tort Claim form was discussed. Adoption of the revised forms will shorten the extended reporting period as opposed to taking no action and extending the statute almost indefinitely for dates of loss after January 1, 2009. Samples of these forms were previously sent out to all OSS members.
- A new online special education course known as Exceptional Child is now available through Keenan Safe Schools.
- AB1719: Beginning in the 2018/19 school year, California school districts that require a course in health education for graduation from high school must include in that course instructions in performing compression-only cardiopulmonary resuscitation (CPR).
- School Bus Child Safety Alert System Regulations requires that all school buses, school pupil activity buses, youth buses and child care vehicles must be equipped with a Child Safety Alert System (CSAS) to prevent children being left unattended on buses.

2018/2019 PRELIMINARY POOL CONTRIBUTION SPREADSHEET

Tom Russo presented the NCR Preliminary Pool Contribution Spreadsheet to the Board of Directors for their review and recommendation for approval by the Executive Committee. Overall OSS realized a 13.8% increase in their renewal premium from various increases in exposure such as Lottery ADA, Property TIV, EDP TIV, and increase in the OSS Liability ex-mod due to claim activity. Without the change in exposure, preliminary net NCR increase was 12.3%. Each individual member would have their own unique set of exposure circumstances directly affecting their renewal premium. Tom stated this was a preliminary indication as the excess rates have not yet been finalized and for the members to budget an additional \$1.00 per ADA to their estimated contribution.
