



Risk Management Reward Program

2017/2018

In a continuing effort to protect our children and reduce child abuse, Keenan in partnership with SAFER has created a micro-learning series. This series is designed to help schools take the next step, beyond the required Mandated Reporter training, to provide enhanced training that increases awareness to prevent child abuse in the school community.

Created by Diane Cranley, Child Sexual Abuse Consultant, the micro-learning modules are 3 to 5 minutes in length and are customized to elementary, middle and high school levels. The modules focus on the sexual abuse problem, how to identify predators/the grooming process, isolation and boundaries.

The Risk Management Reward Program was created to recognize and reward member district's proactive efforts to reduce frequency and severity through utilization of Keenan SafeSchools online trainings modules. Each year the parameters of the program are evaluated to determine what KSS courses would benefit the membership most due to claim trends.

The Risk Management Committee revised the 2017/2018 RM Reward Program criteria to highlight the new micro-learning series and are requesting members take the first two courses titled:

- Child Abuse Prevention: Introduction
- Child Abuse Prevention: Grooming Part I (Choose one: Elementary, Middle or High School)

Districts that meet the eligibility criteria for course completions from July 1 and December 31, 2017 will be entered into a lottery drawing to receive \$2,500!! 10 districts will be chosen in the lottery drawing.

Risk Management Reward Program Guidelines

Purpose:

The NCR Risk Management Grant Program is designed in accordance with the NCR Strategic Plan to recognize and reward member district's proactive efforts to reduce frequency and severity through utilization Keenan SafeSchools online trainings modules.

Slogan:

Recognize and Reward your School district for their efforts to promote the benefits of Keenan's SafeSchool training modules.

Award Criteria:

To be determined annually by the NCR Risk Management Committee

2017/2018 Program Funds:

Program Year funds: \$25,000

Individual Awards: \$2,500/district, 10 District Maximum

- Lottery drawing to determine the 10 Districts

Award monies are eligible for any education related business.

Parameters:

Qualification Criteria: Keenan SafeSchool users with the following two course completions between 7/1/2017 to 12/31/2017 per district and a Saturation Rate of 50% or higher:

- Child Abuse Prevention: Introduction
- Child Abuse Prevention: Grooming Part 1: (Choose one: Elementary, Middle or High School)

Saturation Rate = Total users with two micro-learning series course completions.

Eligibility Requirements:

- Current on all NCR program contributions
