9.	Climbing apparatus free of sharp edges		
10.	Cushioning material under all equipment

16.	No dirt or water flowing on sidewalk		
17.	Area free of debris and broken glass		
18.	Shrubs and trees no branches hanging over walkways		
19.	Fencing free of sharp corners and edges		
20.	Field is level, free of holes and foreign objects		
21.	Sprinklers in proper repair and not protruding
